The license, if granted, would disturb the peace, order, and quiet of the neighborhood. The request is incompatible with the nature of the surrounding neighborhood. The exterior hours exceed well-established guidelines for ANC 2B and respected by neighboring establishments, especially where establishments abut or are near to residences. The lack of a kitchen is also inconsistent with surrounding establishments and risks exacerbating peace, order, and quiet issues - both interior and exterior.
